PART A - Affidavit

I understand that this sworn statement is required by law because I have applied for a public benefit. I understand that state law requires me to provide proof that I am lawfully present in the United States prior to the receipt of this public benefit. I further acknowledge that making a false, fictitious, or fraudulent statement or representation in this sworn affidavit is punishable under the criminal laws of the State of Colorado as perjury in the second degree under Colorado Revised Statute 18-8-503 and it shall constitute a separate criminal offense each time a public benefit is fraudulently received.

PART B - Verification of Authorized Identification

Colorado law also requires the applicant for a public benefit to produce for the City of Westminster one of the authorized documents listed below in order to verify lawful presence in the United States.
