IT IS HEREBY ORDERED:


Bail bonds shall be set according to the following schedule **unless** set otherwise by a Judge:

<b>DOMESTIC VIOLENCE ARREST WARRANT/WARRANTLESS ARREST (INITIATING ARREST)</b>	
Criminal Charges with Domestic Violence Designation	<b>NO BOND</b>
<b>DOMESTIC VIOLENCE – INITIAL BOND SETTING</b>	
Criminal Charges with Domestic Violence Designation	<b>\$1,500</b>
<b>CRIMINAL CHARGES – ARREST WARRANT/ WARRANTLESS ARREST (INITIATING ARREST)</b>	
Assault	<b>\$750</b>
Battery	<b>\$750</b>
Concealed weapon (firearm or knife)	<b>\$750</b>
Criminal mischief	<b>\$750</b>
Criminal tampering	<b>\$750</b>
Discharge of firearm	<b>\$750</b>
Disorderly conduct (W.M.C. 6-2-1(A)(4) and 6-2-1(A)(5))	<b>\$750</b>
Engaging in a riot	<b>\$750</b>
False imprisonment	<b>\$750</b>
False reporting to authorities	<b>\$750</b>
Fraud by check (if between \$50 and \$500)	<b>\$750</b>
Harassment	<b>\$750</b>
Illegal weapons	<b>\$750</b>

Obstruction of the seeking emergency assistance	<b>\$750</b>
Prohibited acts; graffiti (W.M.C. 6-16-3(A) only; defacement)	<b>\$750</b>

Theft (if between \$50 and \$500)	<b>\$750</b>
Trespass (if in a motor vehicle or the premises are fenced or otherwise enclosed in a manner designed to exclude intruders)	<b>\$750</b>
Violation of Bail Bond Conditions	<b>\$750</b>
<b>ANIMAL CHARGES</b>	
Abandoning animals	<b>\$500</b>
Cruelty to animals	<b>\$500</b>
Fighting animals	<b>\$500</b>
Interference (W.M.C. 6-7-16)	<b>\$500</b>
Neglect of animals	<b>\$500</b>
Poisoning	<b>\$500</b>
Potentially dangerous animals	<b>\$500</b>
Vicious animals	<b>\$500</b>
<b>TRAFFIC CHARGES</b>	
Eluding or attempting to elude police officer	<b>\$1500</b>
Involves death or bodily injury	<b>\$1500</b>

- Nothing in the above schedule prevents the court from issuing a Personal Recognizance (PR) bond as appropriate.
- Furthermore, all other offenses/violations are to receive a \$500 PR bond.
- 1<sup>st</sup> failure to appear on a non-VRA summons shall receive a show cause setting or warrant with attached PR bond; 2<sup>nd</sup> or subsequent failures to appear shall receive an increased PR bond or cash/surety warrant as appropriate under the circumstances.
